TERMS & CONDITIONS DETAILS**

<p>Your Responsibilities: By signing this Agreement you agree: a) to pay us all sums, fees, tuition and charges specified in this Agreement, (the "Fees") when due, irrespective of the amount of use you make of our services or the Facility; b) to all the terms and conditions which are set out in this Agreement, c) to follow our rules and regulations ("Rules") which are for your benefit and protection and must be complied with by all Students and Families which may be posted online and may change from time to time, d) to notify us at least fifteen (15) days prior to any changes made with respect to the above pre-authorized account(s), e) to allow Arts Integra to use photos, video or recordings of yourself and/ or your children/ward for promotional or other uses at any time,; f) to keep yourself and your children home if ill,; g) to attend all scheduled lessons and ensure that you or your child bring all appropriate instruments, repertoire and materials to class, and h),: to immediately notify us of address changes and of any other personal information changes. Registration Forms must be completed in full and returned by March 1st, 2011 in order to secure your place.</p> <p>Pre-Authorized Payment Agreement: You agree to pay the Fees as outlined on this Registration & Enrollment Agreement (as applicable) and authorize Arts Integra to present transactions for payment against your account. In consideration of Arts Integra acting as directed, you agree that Arts Integra's treatment of each cheque or financial transaction and our rights to it, shall be the same as if it were personally signed by you. The pre-authorized payment shall be drawn on your account to cover all Fees and any additional charges as they arise. This authorization allows us to initiate a reversal entry to credit or debit a client's account in the event that an error or default occurs. <p>Accompanists: Participants are required to provide their own accompanist for Master classes and performances, without remuneration or payment for incidental expenses. Accompanists and their requirements are the responsibility of the entrant. Acoustic or digital piano accompaniment is required for all solo entries. They are the only forms of accompaniment permitted, unless otherwise specified.</p>	
<p>Attendance: Students are committed for the classes they have registered. Missed classes will not be made up. Arts Integra will not refund any unused or used lessons, classes, fees and/ or related expenses purchased at the point of sale, unless cancelled within 5 days from the Registration Date and accompanied with a dated letter of cancellation, subject to a \$50 charge per cancelled class.</p>	
<p>Change of Contact Information: It is essential that you notify Arts Integra of any change of address following submission of any entry form.</p>	
<p>Copies of Repertoire: Participants must provide a copy of their repertoire for the Master Teachers.</p>	
<p>Da Capo & Dal Segno Signs: Da Capo and Dal Segno indications must be observed at all levels in order to maintain the integrity of the composer's intended presentation as much as possible.</p>	
<p>Dishonored Cheque Charge: Returned payments and any late charges will be automatically charged to your credit card and/ or your bank account. You agree not to apply any charge backs to this credit card. We will apply an administration fee of \$50 or the maximum amount permitted by law, including our costs and expenses; whichever is greater, for changes, returned cheques, NSF or credit card charges.</p>	
<p>Disturbances: Faculty members have the authority to expel anyone whose behavior is deemed inappropriate or distracting at any time, without refund. Anyone who detracts from a performance or adjudication or is in any way disruptive will be expelled from the performance or program with no refund given. Arts Integra reserves the right to substitute or appoint additional clinicians without notice, at any time.</p>	
<p>Donations: Please consider making a generous donation along with your entry. All donations collected during the Arts Integra Master Classes in New Liskeard will be offered as scholarships for students from this community to attend the Arts Integra International Summer Program for Emerging Artists to be held in Markham, ON from July 4-8, 2011.</p>	
<p>Fees: The Executive Committee shall establish the price of admission to any Arts Integra program or performance. Appropriate Entry Fees must accompany each entry registration, and includes a \$10 processing fee per registration. Contestants may submit as many selections as they like. Once a registration is submitted, fees are non-refundable for any reason.</p>

Without limiting the generality of the foregoing, I further agree that my appearance or that of my child/ward in any Arts Integra Program, confers on me or my child/ward no ownership rights and I agree that I will receive no compensation of any kind as a result of any appearances, photographs, pictures, videos, recordings, rebroadcasts, or other broadcasts or non-broadcast uses thereof. I waive any claims for defamation or invasion of privacy for any use of either my name or that of my child/ward or of the recordings, media or pictures, and I further consent, acknowledge and agree that Arts Integra is the sole owner of all intellectual property rights in and to the recordings, media or pictures and all negatives, photographs, images and reproductive product however created, related to, arising out of, or in respect of the recordings, videos, media or pictures. This grant and release is to be construed in accordance with the laws of the Province of Ontario.</p> <p>5. I have read the foregoing and fully understand the terms and conditions contained therein and agree that it is intended to be as broad and inclusive as is permitted under the laws of the Province of Ontario and that if any portion thereof is held to be invalid, the remaining provisions shall continue to be in full force and effect.</p> <p>6. <p>Master Classes: Master Classes are offered in a stimulating and encouraging environment that foster confidence and personal growth with regards to teamwork, artistic understanding, responsibility, self-discipline and artistic expression. Master Teachers offer invaluable feedback and assess the strengths and weaknesses of each performance, including recommendations for improvement.</p>		
<p>Master Teachers & Clinicians: All Arts Integra Faculty, Master Teachers and clinicians are highly regarded Educational and Performing Arts Professionals of the highest standard of excellence and artistic integrity. They are considered specialists in their respective fields, dedicated to providing any interested individuals, regardless of previous experience, their skills and knowledge in a Master Class setting.</p>		
<p>Offences: Arts Integra may, at its discretion, eliminate any entry for any reason, which may include profane references to a deity, obscene language, or content, which may be deemed offensive or incompatible with the aims and objectives of any program. Faculty will also have the authority to expel anyone whose behavior is deemed inappropriate or distracting at any time, without refund. The decision of the Executive Director is final in this and all other matters.</p>		
<p>Payment Obligations Absolute: You are obligated to pay us the entire balance owing under this Agreement. We will not reduce, discount or cancel your obligation because you do not attend the scheduled lessons, performances or classes.</p>		
<p>Privacy: Your signature on this document provides your consent for Arts Integra to collect, use and disclose this information (including information required to administer customer agreements and financial arrangements) to provide ongoing customer service and update you with Arts Integra news, promotions or anything else we think may be of interest to you.</p>		
<p>Photographs, Recordings & Cell Phones: The concentration of performers and Master Teachers must be respected at all times. All electronic, visual or audio recording equipment including photography, flash, lighting, cell phones, pagers, blackberries and cameras, are strictly prohibited in the performance hall while the class is in progress, during adjudications or during any Arts Integra event except as authorized in advance by the Arts Integra office. Please be sure to turn off any electronic devices before entering the Master Class or performance venue. Anyone caught using any photographic or recording devices will be removed from the premises, and no refund will be given.</p>		
<p>Reservation of Rights: We reserve the right to cancel any enrollment without cause, in which event you will be entitled to a refund only of unused prepayments, if any. We reserve the right at any time to substitute or appoint additional faculty without notice, and/or alter times, durations of performances, dates and venues and/or places of operation, and to change the cost of, add, combine, modify and/or eliminate any lesson, class, program, performance, activity or class of service at any time. We reserve the right to refuse to teach a lesson or class should the student not bring the appropriate instrument, repertoire or materials to class, in which event there will be no refund.</p>		
<p>Special Needs Participants: Special Needs participants are individuals who require assistance for disabilities, which may be medical, mental, developmental, intellectual or psychological. Faculty members wish to be sensitive and encouraging to all special needs participants. Please include a brief explanation of the special needs participant upon registration.</p>		
<p>Supervision: Conductors, parents, guardians, or delegated members of the teaching staff must be directly responsible for their wards from the time of arrival to departure. Each group and/or ensemble entry must secure and provide adequate supervision of students at all times to ensure an appropriate level of respect for all performances, and property at Master Class and performance venues. Adult supervision must be present at all times. Participants must conduct themselves with the highest levels of deportment at all times. Anyone who detracts from a performance or adjudication or is in any way disruptive will be expelled from the performance and competition with no refund given.</p>

<p>Master Teachers have the right to stop or start a performance at any time, and may choose to hear only a portion or portions of works to be played.</p>		

Performances must adhere to the time limit specified for each class. The performance may be stopped if this limit is exceeded. Accurate performance times must include assembly, tuning, warm-up and performance, and must be included on the registration form.
